Editorial

Dear Shareholder,

On the 25th of July, Air France-KLM presented its second quarter results. The revenues increased by 4% to €7.9 billion while the Olympic Games showed its first impact, resulting in €40 million less unit revenue. The unit cost went up by 1.7% compared to last year. However, the increase was below our own expectations of +2%. In combination with a higher fuel price than last year, this resulted in an operating result of €513 million. The operating result was €220 million below the result of last year, but at the same time it was the third best second quarter operating result in the history of the Group.

Although we were looking forward enjoying the Olympic Games in Paris, for our business the event is in the short term less positive. In the third quarter we estimate €150m - €170m less unit revenues because international travelers are avoiding Paris and residents in France seem to have less appetite to travel before and during the Olympic Games. However, in the fourth quarter the bookings are at the same level as last year which is

encouraging.

We have reduced our capacity outlook for the full year to +4% compared to last year. Due to less capacity, the unit cost increase is now estimated at +2% versus last year. Our net investments are expected to stay below €3 billion by the end of the year.

I wish you a summer full of beautiful sports at the Olympic Games and later at the Paralympics and I hope to see you on board in one of our aircraft on your way to your holiday destination!
